A student who would like to receive honors credit for COMM 1545, Communication Theory & Practice, must take several steps:

1. Request permission from instructor for honors credit.
 - a. Instructors are not compelled to agree to participate.
 - b. Request to instructor must occur during the first two weeks of the semester.
2. Obtain and fill out the “Request for Contract Honors Credit” form.
 - a. Materials are available at the University Scholars & Honors Office in Cafaro House, or by calling extension 2772.
 - b. Or by clicking the following link:
<http://www.yosu.edu/honors/files/documents/Contract%20Honors%20Form%20Updated.pdf>
 - c. This requires consultation between student and faculty member.
 - d. The Department Chair must also sign the form.
 - e. The form must reach the Honors Office by a specified date listed on the form (around the third week of class).
 - f. The student will be contacted if the proposal is not approved.
3. Discuss with instructor criteria for Honors Credit in COMM1545.
 - a. The student must videotape an additional 12–15 minute informative or persuasive speech. Students must make an appointment at the Communication Support Center (Maag room 138) to tape their speech in an available Center for Communication Excellence classroom.
 - b. *In addition to their regular requirements* for an informative or persuasive speech, this speech should also do more.
 - i. The speech topic must focus on a concept from the 1545 textbook.
 - ii. The speech must cover material in greater depth than in other speeches.
 - iii. The speech should emphasize complex concepts and stress analysis.
 - iv. The speech must evidence a minimum of eight research sources. Sources should be of varied type and excellent quality. A maximum of six sources from the Internet are allowed. At least one personal interview is required.
 - v. Appropriate and professional presentation technology (i.e., PowerPoint) must be used.
 - c. It is the student’s responsibility to either tape the speech and upload their video to youtube and make the speech available to the instructor OR if the instructor deems there is time, the student may give the speech in class.
 - d. The instructor will review the speech, evaluating the student’s performance.
 - e. To receive honors credit, the speech must be worthy of a grade of “A.”
 - f. To earn a grade of “A,” the student may repeat the speech and taping only once. ***Please note: The student may NOT repeat the speech in class twice. If the speech is presented in class first, the student has the option to record and upload the speech to youtube for the second attempt.***
 - g. Any student work deemed unoriginal will constitute an automatic “F” in the course.
4. Fulfill the written contract between student and teacher prior to finals week.
